



## Jeffrey Jackson Law Details Nashville Drug Zone Risks

NASHVILLE, TN - September 11, 2026 -

The Law Office of Jeffrey Jackson has issued guidance for Nashville and Davidson County defendants on two legal factors that frequently determine the outcome of drug cases in Tennessee: the Drug-Free School Zone Act and the distinction between constructive and actual possession.

Under Tennessee's Drug-Free School Zone Act (T.C.A. § 39-17-432), a felony drug offense committed within 1,000 feet of a school, daycare center, public library, recreational center, or park is elevated by one classification, meaning a Class C felony becomes a Class B felony and a Class D felony becomes a Class C felony. The Tennessee Supreme Court confirmed in *State v. Linville* (2022) that this enhancement applies regardless of whether the defendant intended to commit the offense in the zone or even knew they were within its boundaries. Because much of Davidson County falls within 1,000 feet of a protected facility, Nashville defendants arrested in residential neighborhoods, apartment complexes, or commercial corridors may face enhancement triggered by proximity alone, making the geographic facts of an arrest as significant as drug quantity or type.

The firm notes that the enhancement has drawn prosecutorial reconsideration in Nashville. Following reforms

to the Act, the Nashville District Attorney's Office pursued resentencing for 21 Davidson County defendants in one wave, removing school zone enhancements and saving an estimated 198 prison years. As a Nashville Drug Crimes Lawyer, founding attorney Jeffrey Jackson draws on more than seven years as a Nashville Assistant District Attorney to identify which enhancement arguments the DA's office pursues aggressively and which it has retreated from.

A second contested element is possession itself. Tennessee drug charges require proof of either actual possession, meaning drugs found on a defendant's person or immediate belongings, or constructive possession, which the Tennessee Supreme Court defined in *State v. Ross* as the ability to exercise dominion and control over drugs not on the defendant's person. Constructive possession is most commonly disputed when drugs are found in a shared vehicle, hotel room, or residence with multiple occupants.

"As a Nashville ADA, the decision to apply the school zone enhancement often depended on the proximity evidence and the strength of the underlying charge, and defense attorneys who do not understand how those charging decisions are made miss the chance to challenge the enhancement before it becomes part of the formal charge," said Jeffrey Jackson, Founding Attorney at The Law Office of Jeffrey Jackson. "The same is true of constructive possession. When drugs are found in a car with several occupants or a hotel room rented by the defendant, the state's strongest evidence is the circumstantial connection, and challenging that connection requires understanding how prosecutors build their inference chain from arrest through indictment."

The firm also emphasizes collateral consequences that extend beyond a criminal sentence, including professional license suspension, loss of federal student aid eligibility, public housing disqualification, immigration consequences for non-citizen defendants, and enhanced penalties for future charges. The firm addresses these factors from the initial consultation rather than after a plea is entered.
